## Visitation remains suspended at Essex County Sheriff's Department facilities

Visitation remains suspended at all Essex County Sheriff's Department facilities, including the Middleton Correctional Center, the Lawrence Pre-Release Center, and the Salisbury Women in Transition Center.

Please note the change to bail processing.

During this time:

- Inmates will be granted two (2) free 30-minute calls each week during these restrictions. Procedures are in place to allow for additional time for inmates to make calls.
- Commissary deposits should be made online at [www.ConnectNetwork.com](http://www.ConnectNetwork.com), or by phone at 1(888) 988-4768. In-person payments may be made at the kiosk in the lobby of our Middleton facility ONLY.
- Attorney visits continue at the Middleton facility, but will remain as non-contact visits. Attorney visits in Lawrence and Salisbury will be modified to allow safe distance between the parties for medical reasons.
- Bails will now be made Monday through Friday at 9 p.m. Weekend bails will occur at 11 a.m. and 9 p.m. on Saturday and Sunday.
- Bail payments must be made by bank check or money order and made to the bail clerk on duty. The \$40 bail fee must be paid in cash.
- The work release program has been suspended temporarily.

Because of the fluid nature of this pandemic, the above matters are subject to change at any time. Information is being shared with the inmate population so that they are aware of current events and changing Department operations.
